The Chinese medical technology (MedTech) market offers incredible opportunity for QualiMed and it is estimated that this MedTech market will reach approximately US\$50 billion by 2017 with a 20% compounded annual growth rate (CAGR). Consumable Medical Products such as implantable devices and catheters are expected to represent over 16% of this market and are expected to grow at a rate of 22% (CAGR) based on PWC's recent 2015 market assessment.

The VMAX Aspiration Catheter is designed to provide an efficient and effective solution for thrombus removal, and offers excellent trackability, pushability, and aspiration volume. It is a rapid exchange type catheter used for the removal of thrombus and debris in the coronary or peripheral arteries via percutaneous suction.

#### **PTCA Device**

The PYXIS-c PTCA Balloon Catheter is a semi-compliant rapid exchange catheter and indicated for the luminal restoration of de novo and restenotic narrowings and occlusions of native coronary arteries for pre and post stent placement.

We believe this initial product launch will set the stage for future product approvals in the coming years as we expand our presence in China.
